

PRIVACY POLICY

(Effective March 10, 2014)

Huntsville Utilities respects your right to privacy. We recognize the need for appropriate protection and management of personally identifiable information shared with us (for example, your name and contact information).

INFORMATION WE COLLECT

In order to serve you and effectively process your transactions, Huntsville Utilities collects information from you. Some of this information may be personally identifiable information. For example, we collect information that you provide when you pay a bill, create an account, or call us with a question, such as your name, your address, your telephone number, your email, and your bank account information. Huntsville Utilities may also collect information related to your use of our Website, such as your IP address, your browsing behavior, and your browser or device characteristics. This information is used to enhance the online experience of our customers. We may use cookies or applets to recognize you when you visit our sites, to personalize your experience and generally to serve you better. Cookies are identifiers which a website sends to your browser to keep on your computer to facilitate your next visit to our site. These technologies do not use or collect personally identifiable information, such as names or address, and do not link online actions to an identifiable person. We do not use cookies or applets to track your activities once you leave our web site. You may delete these files from your computer at any time. You can also set your browser to notify you when you are sent a cookie, so that you can choose to decline or accept it. We reserve the right to use third party analytical tools to monitor use of the Website.

HOW WE USE THE INFORMATION

Huntsville Utilities only collects the information it needs to serve you effectively and to process your transaction. Huntsville Utilities may retain the content of any customer service web form or email that Huntsville Utilities receives, the email address from which it is sent, and Huntsville Utilities' response, if any. Huntsville Utilities will not use any bank account information supplied by its customers for any other purpose beyond the services provided on this site. Huntsville Utilities undertakes no obligation to store, maintain, or provide you a copy of any information that you or other users provide when using the Website.

Generally, Huntsville Utilities will not disclose your personal information provided in your account registration to third parties. However, Huntsville Utilities may access, preserve and disclose your registration and any other information you provide if required to do so by law or in a good faith belief that such access, preservation or disclosure is reasonably necessary in Huntsville Utilities' opinion to: (a) comply with the law, our regulators or legal process, including, but not limited to, civil and criminal subpoenas, court orders or other compulsory disclosures; (b) respond to claims of a violation of the rights of third parties, whether or not the third party uses the Website; (c) respond to customer service disputes or inquiries; (d) enable Huntsville Utilities' employees or representatives to provide service to you or otherwise perform their duties; (e) comply with interchange functions; (f) obtain and provide credit reporting information; or (g) protect the rights, property, or personal safety of Huntsville Utilities, its users

or the public. If Huntsville Utilities contracts with third party service providers to perform functions on our behalf such as delivering packages, sending mail and e-mail, or processing credit card payments, then these providers will only have that access to your personal information needed to perform their functions. Huntsville Utilities does not sell your personal information to third parties for telemarketing, e-mail or direct mail solicitation of third party products or services.

INFORMATION SECURITY

A. By Huntsville Utilities. Your personal information is stored on our servers in the United States. Huntsville Utilities takes what it believes to be reasonable precautions to protect its users' information, including off-line measures to protect your information that is known to Huntsville Utilities to be financial and business sensitive information to the same extent that we take measures to protect our own such information. Unfortunately, no security system can be guaranteed to be 100% secure. Accordingly, we cannot guarantee the security of your information and cannot assume liability for improper access to it.

B. By You. Do not divulge your user ID or password to anyone. Huntsville Utilities will never ask you for your user ID or password in an unsolicited telephone call or in an unsolicited e-mail. Remember to sign out of your account (if you have one) and close your browser window when you have finished with the Website. This may help to protect against access by others to your personal and business information if you share a computer or are using a computer in a public place. If you do share your password or your personal information with others, then remember that you are responsible for all actions taken in the name of your account. If you lose control of your password, then you may lose substantial control over your personal information and may be subject to legally binding actions taken on your behalf. If your password is compromised, then you should immediately notify Huntsville Utilities and change your password.

WARNING ABOUT "PHISHING"

Huntsville Utilities may periodically send you email to provide energy saving ideas and other useful information, updates regarding our services, and special offers. We may also call the phone number associated with your account. However, we will not request any of the following information via an unsolicited email:

- Your user ID;
- Your password;
- Your social security number; or
- Your bank information

In addition, we never will send you an unsolicited email containing a link to the login page for our Website.

If you receive an email requesting any of this information, then it is likely that you have received an attempted theft of your identity commonly called "phishing." You can notify us of the phishing attempt by completing this [form](#).
